Dear Prime Minister, Mr. MacKinnon and Dr. Ireland,

Humane Canada is the federation of Humane Societies and SPCAs. We represent 54 members from every province and two territories, from rural and urban environments. Our Members are the organizations that Canadians depend upon, not only to care for abused and abandoned animals, but also to advocate for greater care and protection of animals and to provide community resources, research, and humane education. Humane Societies and SPCAs are among the oldest and most trusted social institutions in the country with more than 150 years of service.

We are opposed to the live export of horses overseas for slaughter and have witnessed on Bill C-355 at the House of Commons Standing Committee on Agriculture and Agri-Food. We have been disappointed by the CFIA's lack of adequate data and tracking of the horses shipped overseas for slaughter.

Recently, through Access to Information requests, the Japanese government has confirmed that in the last year (May 2023 to June 2024) 21 Canadian horses died on route to Japan or shortly after landing and many others were injured. Animal Justice received official documents from the Japanese government, originally obtained by a local organization, which lists dehydration, stress, pneumonia, compression and even miscarriages as the cause of these deaths. contradicts CFIA reports which indicate only 5 horse deaths related to air shipments to Japan since 2013.

Given the scope of horse injury and death and the lack of adequate oversight and monitoring on behalf of Canada, we ask for an immediate, permanent termination of all live exports of horses from Canada by air for slaughter.

Furthermore, we ask that the CFIA undertake a swift and thorough investigation into the discrepancies between Canada's data and Japan's data and release a public report reflective of the accurate number of injuries and deaths and the number of times the transportation regulations were violated.

We appreciate a prompt response and request a meeting at your earliest convenience.
